**RESOLUTION NO. 20-34 of 2020**

**A RESOLUTION OF THE COUNCIL OF THE MUNICIPALITY OF NORRISTOWN AUTHORIZING THE SUBMISSION OF A GRANT APPLICATION TO THE PENNSYLVANIA DEPARTMENT OF CONSERVATION AND NATURAL RESOURCES FOR THE NORRISTOWN RIVERFRONT PARK PROJECT.**

**WHEREAS**, the Municipality of Norristown (“Municipality”) desires to restore, rehabilitate, update and improve resources and facilities at Riverfront Park (the “Project”); and

**WHEREAS**, the Municipality desires to receive from the Department of Conservation and Natural Resources (the “Department”) a match grant in the amount of Two Hundred and Fifty Thousand Dollars (\$250,000) for the purpose of carrying out this Project; and

**WHEREAS**, the Municipality understands that as a match grant, the Municipality will be required to match 50% of any grant dollars awarded for the Project, which matching funds may be made through the Municipality’s CIP funding; and

**WHEREAS**, the grant application package includes a document entitled “Terms and Conditions of Grant” and a document entitled “Grant Agreement Signature Page” and the Municipality understands that the contents of “Terms and Conditions of Grant” document, including appendices referred to therein, will become the terms and conditions of a Grant Agreement between the Municipality and the Department if the Municipality is awarded a grant; and

**NOW, THEREFORE, BE IT RESOLVED** by the Members of Council of the Municipality of Norristown, that the Municipal Manager or his designee is hereby authorized and directed by Council to submit an application to Department of Conservation and Natural Resources for a match grant in the amount of Two Hundred and Fifty Thousand Dollars (\$250,000) for the Norristown Riverfront Park Project; and

**BE IT FURTHER RESOLVED**, that the Council of the Municipality of Norristown agrees to, if selected, provide a 50% match of the total project cost awarded; and

**BE IT FURHTER RESOLVED**, as follows:

1. The “Grant Agreement Signature Page” may be signed by on behalf of the Municipality by Crandall O. Jones, Municipal Administrator, or by Derrick Perry, President of Municipal Council for the Municipality of Norristown (“Official”).

2. If this Official signed the “Grant Agreement Signature Page” prior to the passage of this Resolution, this grant of authority applies retroactively to the date of signing.
3. If the Municipality is awarded a grant, the “Grant Agreement Signature Page” signed by the above Official, will become the Municipality/Grantee’s executed signature page for the Grant Agreement, and the Municipality/Grantee will be bound by the Grant Agreement.
4. Any amendment to the Grant Agreement may be signed on behalf of the Grantee by the Official who, at the time of signing of the amendment, has the title specified in paragraph one, and intends to be bound by the amendment.
