RESOLUTION NO. 22-19 of 2022

**A RESOLUTION OF THE MUNICIPALITY OF NORRISTOWN, MONTGOMERY COUNTY, PENNSYLVANIA, TO APPROVE THE INTERGOVERNMENTAL AGREEMENT WITH THE NORRISTOWN MUNICIPAL WASTE AUTHORITY RELATING TO PERFORMANCE OF A SANITARY SEWER SYSTEM EVALUATION BY PENONNI ENGINEERING.**

**WHEREAS**, the Municipality of Norristown, Montgomery County, Pennsylvania (the “Municipality”) is a Home Rule Municipality, which Home Rule Charter authorizes Council to enter into agreements from time to time and the Pennsylvania Intermunicipal Cooperation Law, 53 Pa. C.S.A. §§2301 et seq., was amended to allow municipalities to adopt and approve participation in intergovernmental agreements by resolution; and

**WHEREAS**, the Norristown Municipal Waste Authority (“Authority”) is a municipal authority that is also permitted to enter into agreements with other governmental units such as the Municipality in accordance with the Pennsylvania Intermunicipal Cooperation Law; and

**WHEREAS**, the Municipality and the Authority are in need of an evaluation of the existing Municipal Sanitary Sewer Gravity Collection/ Conveyance System in order to assist in identifying potentially substandard and/or compromised portions of the System in order to develop a future capital improvements plan (“CIP Eval Project”) necessary to address identified issues; and

**WHEREAS**, the Municipality desires to engage Pennoni Engineering to perform the CIP Eval Project in accordance with a proposal dated October 8, 2021, at Municipality’s sole cost, and the Authority desires to assist Pennoni Engineering in performing said work by allowing Pennoni Engineering access and information as requested.


**NOW, THEREFORE, BE IT RESOLVED** by the Members of Council of the Municipality of Norristown, that Municipal Council hereby approves the Intergovernmental Agreement with the Norristown Municipal Waste Authority as attached hereto as Exhibit “A,” and that the Municipal Administrator, or his designee, is authorized to take all action to effectuate the execution of this agreement and any related documents.
